

## SWORN INFORMATION

*Laid Under Section 504 of the Criminal Code of Canada*

Ontario Court of Justice — Perth, Ontario

**April 16, A.D. 2026**

---

### The Proceeding

On the morning of April 16, A.D. 2026, the undersigned attended the Ontario Court of Justice at Perth, Ontario, and laid a private Information under section 504 of the *Criminal Code* of Canada. The Information was sworn on the Bible before Justice of the Peace A. Colterman.

The Information names thirty public officeholders in their personal capacities across six indictable counts:

**Count 1** — Breach of Trust by a Public Officer, contrary to s. 122 of the *Criminal Code*;

**Count 2** — Fraud Over \$5,000, contrary to s. 380(1) of the *Criminal Code*;

**Count 3** — Obstruction of Justice, contrary to s. 139(2) of the *Criminal Code*;

**Count 4** — Disobeying a Statute, contrary to s. 126(1) of the *Criminal Code*;

**Count 5** — Extortion, contrary to s. 346(1) of the *Criminal Code*;

**Count 6** — Participation in a Criminal Organization, contrary to ss. 467.1 and 467.11 of the *Criminal Code*.

The thirty named accused are current and former holders of the offices of Minister of Justice and Attorney General of Canada, Prime Minister, Minister of Public Safety, Commissioner of the Royal Canadian Mounted Police, and Director of Public Prosecutions, spanning approximately fifty years of the continuing offence.

### The Constitutional Foundation

The Information rests on a single constitutional proposition: the pre-existing liberties of natural persons — including the liberty to keep and bear arms — are anterior to the Canadian constitutional order, received at Confederation by the preamble to the *Constitution Act, 1867*, and placed beyond the reach of ordinary legislation by s. 52(1) of the *Constitution Act, 1982*. These liberties have never been lawfully extinguished. The *Firearms Act*, S.C. 1995, c. 39, and the Orders in Council made under it, purport to condition, licence, prohibit, and confiscate what they have no constitutional jurisdiction to reach. The instruments are void *ab initio* as against every natural

person who is a rightful Heir to Canada's constitutional order, bound by natural allegiance (*ligeantia naturalis*).

The relationship between the Crown and the Heirs is one of constitutional trust: the offices of state are the trustees, the Heirs are the beneficiaries, and the pre-existing liberties are the corpus. When a trustee extracts from the corpus — by conditioning, licensing, prohibiting, or confiscating what the beneficiary holds by inheritance — the trustee commits breach. When the breach is knowing, it is criminal. After notice, every act in continuation of the encroachment is taken *sciemment*.

## **Documents Tendered to the Court**

The following documents were physically tendered to the Court and received by Justice of the Peace A. Colterman during the proceeding of April 16, A.D. 2026. They are now part of the court record in the Province of Ontario:

1. The sworn Information, comprising the six counts, the particulars, and the constitutional trust architecture supporting the charges.
2. Two printouts of RCMP Canadian Firearms Program email communications, cryptographically authenticated by DKIM/DMARC/SPF chain, constituting Crown admissions in the Crown's own digital signature.
3. The original *Ottawa Citizen* full-page legal notice, print edition of April 13–14, A.D. 2026 (Order No. OTC013118), establishing the public record of notice to the Crown's chief law officer and the scianter date.

The Informant's Possession and Acquisition Licence (PAL) was presented to the Court as identification and proof of standing but was not retained by the Court.

## **The Disposition**

Justice of the Peace A. Colterman elected to terminate the proceeding, stating in words to the effect of "no prospect of prosecution." No process was issued. The Information was not referred under s. 507.1 of the *Criminal Code*. No written disposition or reasons for decision have been provided as of the date of this publication, notwithstanding that a written request for a disposition has been delivered to the Court by email with a full chain of non-repudiation of cryptographic delivery. The documents tendered were retained by the Court. Whether these Court documents are being concealed or otherwise is a question that remains open.

## **The Public Record**

The documents reproduced below are published as a public record. They are identical to the documents tendered to the Court on April 16, A.D. 2026. The existence of this public copy ensures that the record cannot be lost, altered, or made to disappear. Any discrepancy between the court's version and the public record is the court's discrepancy to explain.
